

# CITY OF SEDALIA, MISSOURI CITY COUNCIL MEETING JULY 1, 2024

The Council of the City of Sedalia, Missouri duly met on July 1, 2024 at 6:30 p.m. at the Municipal Building in the Council Chambers with Mayor Andrew L. Dawson presiding. Mayor Dawson called the meeting to order and asked for a moment of prayer led by Chaplain Byron Matson followed by the Pledge of Allegiance.

Fire Chief Matt Irwin stated that Kyle Rupe's knowledge of Fire Trucks and pumping equipment surpasses most in the Fire Department and he's the "go to" on anything with operations of the Fire Trucks. He noted that Nathan Deuschle just participated in the Lieutenants testing program.

Police Chief David Woolery stated that Mark Cherry joined the Police Department June 15, 2014 and has established himself as a trainer in fire arms defense tactics, ground fighting, officer wellness and Crisis intervention. He has trained not only our officers but many across the country and worked to develop the CIT program for the Sedalia Police Department.

Finance Director Jessica Pyle presented Jamie Smoot with her service award. Director Pyle noted that customer service comes naturally to Ms. Smoot. She is kind, personable and greets customers by their name and also has the ability to take projects and quickly identify the processes needed to complete them.

The primary organizer for D.A.R.E. approached Fire and Police Chiefs about combining the use for not only fire prevention but also the D.A.R.E. program. All parties discussed and agreed it is a good use of the D.A.R.E. funds through Robotronics Inc. for Police and Fire Departments. The budget amendment and quote allows for the purchase. Cost – \$11,466.80.

Fire Chief Irwin stated that in March of this year, the City had its ISO Inspection and it had to go to a second panel to be reviewed. Anytime a City regresses or progresses, it goes through a second review. The City of Sedalia received an ISO Class 2 rating which takes effect October 1, 2024.

## PUBLIC WORKS - Chairman Bob Hiller; Vice Chairwoman Tina Boggess

The City continues to work on storm drainage improvements through the Master Plan. Projects have been completed as funding allows. This Fiscal Year the City was successful in securing a Grant accelerating the plan. During construction on project area 14, it was discovered by Orr Wyatt Streetscapes that there was an additional pipe not included in plans. In addition, ponding was identified where a drive approach and sidewalk were too low. Cost \$19,390.00.

➤ The City of Sedalia has been utilizing the Main Street Approach<sup>TM</sup> to assist with and encourage the revitalization of downtown. In May, City Council approved an agreement granting the ability to continue use

of their model and tools, while agreeing to their guidelines on use. Main Streets has presented a Trademark Sublicense Agreement allowing the City to use their trademarked materials under their conditions.

#### MISCELLANEOUS ITEMS FROM MAYOR/COUNCIL/ADMINISTRATOR:

Councilman Oldham stated that June 22, 2024, was the Day of Action through Pettis County United Way. There were approximately 350 volunteers doing neighborhood clean up and other projects around Pettis County. He expressed his appreciation to City staff who were there to assist. He also noted that on July 9, 2024, there will be a workshop for the Washington Street bridge.

Councilman Oldham reviewed his discussion from the last Council meeting in support of a 3 station model for the Fire Department. He believes our new ISO rating will be at risk without a 3 station model. Motion by Oldham, seconded by Marshall to move to a 3-Station model.

Councilwoman Foster asked what affect the placement of Fire Stations has in the ISO rating. Fire Chief Irwin stated that there are 105.5 points available to the City as a total score. We are graded at 50% of that score for the Fire Department as a whole. Station placement is in the grading but not at 50% but rather 15. The Fire Department gets 50 points, Water Department gets 40 points, Joint Communications gets 10 points and Community Risk reduction gets 5 points. Fire Chief Irwin stated that the City scored lower on Station deployment (6 out of 10). Points were picked up in training, hydrant flushing, flow testing and pre-planning. In answering if our Class 2 is in jeopardy, the City received a score of 80.97 points of which 80 is the break over from a 2 to a 3. The Class 2 could be in jeopardy due to growth.

What detracted in the inspection was some of the City's annexations, particularly Clover Dell and Missouri State Fair property, relative to lack of hydrants. Points will be gained due to adoption of the 2021 International Building Codes related to Fire Code. It will be 5 years before the City is re-graded.

A three station model would mean figuring out how to support it financially. It is roughly a \$5 Million dollar building plus extra cost for personnel and equipment. If we grow, there will be a need for additional personnel across the board. Councilman Oldham stated that he believes the community is in support of this initiative and has a couple of ideas for financial support if the motion passes. Councilman Hiller stated that he has talked to several individuals who are not in support of another tax and that while the North side would like to have a Fire Station the need is actually South and West based on annexations and to cover homes and the High School. Councilman Robinson feels it is more important to rebuild the Central Fire Station due to its condition.

Roll Call Vote: Voting "Yes" was Oldham. Voting "No" were Robinson, Marshall, Hiller, Cross, Foster and Bloess. Boggess was Absent. Motion FAILED.

### **GOOD & WELFARE:**

Nicci Bullock, 506 Sunset Drive, stated that there is a new car wash and dispensary being built on Broadway and the field behind the houses and the building sites has tall weeds. She is worried about hazards, fire risks and wildlife issues.

David Goodson, 1640 Hedge Apple Drive, stated that their Facebook group is called "Seeing Sedalia Succeed". He thanked City Council members who were able to meet with him to discuss issues, however, none of the issues are being fixed or addressed. Mr. Goodson believes that if businesses were run the way the City is, they would not be in business. He feels there are three positions in the City responsible for the major damage. If growth is expected, make Sedalia more inviting to do business, have growth and developers who want to come here. Important vacancies should include input from citizens to vet candidates to make the appropriate hire and not be a succession plan.

Susan Friese, 1800 East 22<sup>nd</sup>, stated she recently called to complain about a neighbor at 1820 Appletree Lane. He owns a business and is always bringing in large equipment and piping, some of which is stored in his back yard. Eaglebrook Farm is zoned residential. She was told by the City that it is legal to operate a business out of a person's home. According to Section 63-37, regarding residential neighborhoods, "the single-family residential district is intended to provide for low density residential use area developed in a manner that reflects suburban character." Operating a business in a home may be legitimate but bringing in large equipment and materials is not. Ms. Friese asked that the City enforce Ordinances and State Laws that have been passed.

Gary Lobaugh, 821 South Arlington, requested information about the Washington Street Bridge and would like to know if it will be repaired or replaced. He would like it to be fixed so that people have adequate response time now.

Cory City, 1804 South Park, stated that a month ago he requested a list of properties for sale by the City and inquired if it was available yet. The issue with weeds at the corner of Grand and Wilkerson is still not addressed. Mr. City inquired if there is a way to view the ISO scoring. Providing audio of meetings held through the week would be helpful and timely uploading of Council meetings would be great.

Debbie Covington, 2601 East 12<sup>th</sup>, requested that all City meetings be live streamed on the Sedalia Facebook page and website. She asked if City Council was aware that the Landfill is dumping Leachate into the Wastewater Treatment plant which she claims came straight from DNR. She asked if any decision has been made regarding the Water Treatment facilities and if the City will be asking for an additional \$10 Million if they go with Plan B.

Jim Marcum, 21524 Main Street Road, stated he has been speaking with Pettis County Fire Chief Mike Harding about ways they can assist on the North side through mutual aid. They have a station north of town by NuCor and would be glad to assist with fire coverage.

Kevin Lujin, 408 West 22<sup>nd</sup>, commented that when speakers are close to the mic you can hear them much better particularly when watching via YouTube or Facebook. He works at the Windsor Review, Cole Camp Courier and the Lincoln New Era and with the challenges in media now he would encourage City and County to help support local media. He invited any interested Council Members to come speak at the Pachyderm Club. Mr. Lujin commented that this is the 50<sup>th</sup> Anniversary of the Ozark Music Festival and the documentary will be shown in Independence, MO on July 19-21, 2024.

The meeting adjourned at 7:40 p.m. on motion by Oldham, seconded by Foster. Roll Call Vote: Voting "Yes" were Robinson, Oldham, Marshall, Hiller, Cross, Foster and Bloess. No one Voted "No". Boggess was Absent.
