# OFFICE OF THE CITY ADMINISTRATOR

Re: Agenda items for City Council meeting on Monday, December 2, 2024, 6:30 p.m.

<u>Public Safety Committee</u> – There are four items for consideration through the Public Safety Committee.

 Fire Chief, Matt Irwin will continue this year's presentations of strategic planning for each department. Chief Irwin will present at this meeting an overview of the plans for the Fire Department.

As a reminder, I ask that in each of the individual presentations that they address the following four questions:

- a) Why is the service needed?
- b) Why should the City be doing it?
- c) What level of service are we providing now?
- d) How are we going to accomplish it? In other words, strategies going forward for services, including any major budget requests related to new or expanded initiatives.

These presentations will all lead up to and set the stage for the Council strategic planning session on January 11<sup>th</sup> (the second Saturday in January). During this session, we review the highlights of each of these individual department strategic plans to bring them together into an overall plan for the City, to include setting relative priorities. This high-level direction from Council then becomes the basis for the budget development to match that strategy. We will then have budget work sessions February through March, culminating with a budget adoption the last meeting in March.

- Police Chief, David Woolery will continue this year's presentations of strategic planning for each department. Chief Woolery will present at this meeting an overview of the plans for the Police Department.
- 3. An agreement with the Hoefer Welker, LLC architect firm was entered into in November of 2022 to design a new fire station and training center. This was done in accordance with the strategic plans and budget adoptions over the last couple years. Further, as called for in our financial management policies and state statutes, a search for firms through a request for qualifications (RFQ) process was completed that resulted in the selection of this firm. Similarly, the Parks & Recreation Department has gone through a RFQ process to select an Architect to design the aquatics center and bowling alley in accordance with their strategic planning and the generous gift from Sue Heckart. Hoefer Welker, LLC was also selected as the best firm for these projects as well. Since these projects are all on the same site, having the same design firm makes for coordination of the projects to best utilize the available site was a significant deciding factor. Likewise, having the same architect coordinate the projects through-

- out construction offers unique opportunities for cost savings and a better end product. Since a contract already exists with this firm, staff recommends amending this contract to incorporate the added scope.
- 4. Jesse E. White Jr. and Nancy A. White established a trust in 1998, which in part sets aside \$100,000 to be invested and for the income from such investments to be used for "the care and feeding of cats and kittens" in the name of their beloved cat Sophie. Jerusha L. White, as trustee for the trust, has proposed an agreement to help ensure that the wishes of the grantees are adhered to and the funds are put to good use within the intent of the donation. Staff recommends accepting this generous donation by entering into the agreement to abide by the stipulations.

<u>Public Works Committee</u> – There are five items for consideration through the Public Works Committee.

- The City has contracted for several years with the Missouri Department of Conservation, to include an agreement through the Parks and Recreation Department for the management of fish in the lakes within the parks systems. This is a great service to the community, and staff recommends renewing the memorandum of understanding to continue the arrangement.
- 2. As presented in the strategic plan, staff was successful in obtaining grant funds to offset fifty percent of the costs to rehabilitate approximately 100 blocks of sidewalks in the north central area of the city. The design has been completed, and bids were solicited for the construction. Since the grant application anticipated using the labor our public works crew dedicated to the project as \$198,000 of in-kind towards the fifty percent match, the lowest bid came in \$189,396.16 over the amount of the original set aside for cash match. The bid specifications would allow for deducting enough sidewalk construction to bring it back into the total cost. However, staff recommends allocating enough local cash to go forward with the full amount to complete the project. Staff recommends award of the bid to S&A Equipment & Builders, LLC in the amount of \$1,356,577.66.
- 3. The City has for several years, participated in the Tree City USA program. This program allows us to apply for Tree Resource Improvement and Maintenance (TRIM) grants to help us manage the urban forest. This year, the grant was awarded to assist with planting forty trees in Katy Park and the Animal Shelter grounds, along with equipment to water trees throughout the City, and a flier to provide basic tree maintenance information. Staff recommends acceptance of the \$13,320 grant for these purposes.
- 4. As has been discussed at several Council Meetings, the bridge over the railroad at Washington Avenue needs repairs. In July, a report was submitted to Council for a phased approach to repairing the bridge. In order to proceed with the next phase, the Missouri Department of Transportation (MODOT) has indicated that stamped drawings from a design professional must be submitted to them for their approval and that such drawings shall indicate load rating calculations. Staff has worked with the firm that was engaged for the initial report in July to develop a scope of work that will meet the increased requirements of MODOT. Staff recommends adding \$133,409.00 to the engagement with HDR, Inc. to complete this work. Note that city crews continue the preparation work alongside this design work to shorten the time-line to reopening the bridge to two-way traffic.

5. As discussed in the last item, city crews continue to work to prepare the structural components of the bridge to enable construction to move forward quickly after the design engineer completes their work. Staff has identified a dustless bead blaster that would make this process much more efficient and effective. Further, this piece of equipment can be used going forward for the resurfacing of the walls in the animal shelter and maintenance of painting on streets and parking lots. Staff recommends approval of the purchase of the equipment at a cost of \$55,545.00.

<u>Finance/Administration Committee</u> – There is one item for consideration through the Finance / Administration Committee.

1. The Pettis County Health Center made a request to utilize some of the opioid settlement funds the City is receiving from the ongoing class action suits filed by several states and local governments to offset the costs of dealing with the effects of opioid misuse. The Health Department has proposed a budget of \$50,000 to offset the costs of three outdoor vending machines to dispense Naloxone / Narcan and education materials regarding the use of this medicine to reverse overdoses, along with an outreach program to discourage opioid misuse. After the presentation, Council directed staff to bring back a budget amendment to appropriate these restricted funds for this use.

<u>Community Development Committee</u> – There are no items for consideration through the Community Development Committee.

## CITY OF SEDALIA, MISSOURI CITY COUNCIL MEETING NOVEMBER 18, 2024

The Council of the City of Sedalia, Missouri duly met on November 18, 2024 at 6:30 p.m. at the Municipal Building in the Council Chambers with Mayor Andrew L. Dawson presiding. Mayor Dawson called the meeting to order and asked for a moment of legislative prayer led by Chaplain Byron Matson followed by the Pledge of Allegiance.

#### Presentation - Pettis County Health Center- Opioid Funding

Pettis County Health Center Mental Health Coordinator, Dawn Williams, presented options for enhancing harm reduction utilizing Opioid Funding. In 2023, there were a total of 1,948 deaths in Missouri with 73% attributed to opioids. In the same year, Pettis County had 6 deaths related to opioids. For the United States, over 115 million pills containing fentanyl were seized by law enforcement in 2023. Fentanyl accounts for 97% of overdose deaths involving opioids.

Naloxone is a medicine that rapidly reverses opioid overdose. Prior to the opioid settlement, Pettis County Health supplied first responders with Narcan. Following the settlement, they have been able to supply businesses and the community. The largest hurdles in fighting opioid overdose are the lack of availability of Narcan before and after business hours. Pettis County Health Center is proposing a way to provide Naloxone to the community 24/7 by having harm reduction vending machines throughout Sedalia. This improves access, reduces stigma and is free. Proposed locations are Pettis County Health Center, 911 E. 16<sup>th</sup>, City of Sedalia, 200 South Osage, and a third location to be determined.

Pettis County Health Center solicited and received 4 quotes for the machines. Their recommendation is to accept the quote from AVS Vendors in the amount of \$32,717.00. Pettis County Health Center also plans a 1-year Business Outreach and Education Project. This plan will reach manufacturing and retail businesses offering Naloxone/Narcan and training for use, educate on opioids and signs of overdose. The total proposed funding request utilizing opioid funds is \$50,000.00 (\$37,717.00 for 3 vending machines with AVS Companies and \$12,283.00 for Business Outreach Campaign).

The machines will be maintained and stocked through the Health Center utilizing free Narcan supplied by the state. The machines are outdoor and temperature controlled with a locking mechanism on the outlet. City Administrator Kelvin Shaw stated that while all invoices from the approved Embassy funding have not come through, he is confident that additional monies are coming which could fund this if Council approves. A Budget adjustment would need to be made to utilize the restricted funds. Ms. Williams advised Council the quotes provided only have a one-month pricing guarantee.

#### OATS - Annual Report

Tracy Walkup, Oats Midwest Regional Director, presented the annual report for Oats. The Midwest Region covers 87 counties with the home base in Sedalia. During fiscal year 2024, Oats provided 111,496 local one-way trips. The total direct cost per one-way trip was \$13.49. Trips are up over 50% and costs are up 30%. OATS is a Rural General Public transport service available to all regardless of age or disability, however, are sometimes limited and some routes are consistently full (1% of the population utilizes for transportation to work).

Accomplishments and Partnerships – Participated financially in the depot renovation; under 20-year lease with City; provides Pettis County Community Partnership with 800 \$5 cards/year for low income clients; consists of 21 local drivers, 13 local office staff with an average hourly rate of \$17.61 plus benefits.

Proposal for upcoming year – Maintain fares at the same level, use contracted transportation to match federal funding, utilize federal funds, City of Sedalia contribution of \$25,000 in operating subsidy.

Future of Public Transit in Sedalia – Because of funding coordination, Sedalia stands out as a rural community since not many cities provide 6-day service. Needs will significantly increase with the aging population of Baby Boomers. Funding is always a concern but thanks to Legislators, funding from the state has increased to levels not seen for over a decade. The greatest need is vehicles. The last new vehicle purchase was in 2019. Director Walkup stated that they did receive 8 new minivans this year.

Financial Update: Finance Director Jessica Pyle stated that Sales, Use Taxes and Marijuana Taxes for fiscal year to date are up over prior year of \$1,000,000.00 or 8.6%. A 4% increase was budgeted and when compared to prior year results is a budget variance of \$550,000. The Marijuana tax was an additional 3% sales tax passed by the voters and collection began in October 2023. The first deposit was received in January 2024 so in a few months will have some comparative data. Franchise tax increased over prior year and includes the Charter settlement of \$377,000. The remaining 147,000.00 is related to the gas tax at a decrease of 40.6%. Transportation taxes are higher fiscal year to date as a result of increase Gas Tax of 8.5% Fiscal Year to Date. We have collected some Property Taxes but the bulk of those are collected in December and January.

Motion by Oldham, seconded by Robinson to extend audit services with Williams Keepers for 2 years for the City and Pension Funds. Roll Call Vote: Voting "Yes" were Robinson, Oldham, Boggess, Hiller, Cross and Bloess. No one voted "No". Marshall and Foster were Absent.

Motion by Bloess, seconded by Oldham to award the Insurance Broker for Worker's Compensation, Property and Liability/Ancillary Coverages to IMA Financial Group. All Present in Favor. Marshall and Foster were absent.

#### Strategic Planning Presentation - Animal Services

Animal Shelter Manager Randi Battson stated the Animal Shelter is open Monday-Saturday 12 p.m. to 5 p.m. and Animal Control operates at a minimum from 1 p.m. to 5 p.m. Monday -Saturday. The Animal Shelter has 49 dog kennels, 96 cat kennels and a "Wiggle Room" located behind the Shelter that allows dogs to exercise and develop social skills.

RESOLUTION NO. 2117 – A RESOLUTION AUTHORIZING THE SEDALIA FIRE DEPARTMENT TO SUBMIT AN ASSISTANCE TO FIREFIGHTERS GRANT APPLICATION was read once by title and approved on motion by Oldham, seconded by Robinson. All Present in Favor. Marshall and Foster were absent.

#### Presentation - Safe Streets for All

Michael Cramer and Ashley Winchell, with Wilson & Company, shared the findings and recommendations regarding Safe Streets for All. The plan was established with \$5 billion in funds with a goal to reduce serious injuries and deaths on the nation's highways. This program is a Safe System Approach, includes planning and demonstration grants and implementation grants. You must have the action plan in place to fund implementation.

Sedalia's action plan includes elimination of traffic deaths and serious injuries by 2032, prioritize safe, healthy and equitable mobility for drivers and strategies for the next 8 years to meet Sedalia's evolving needs. A Task Force met to identify Safety Countermeasures and prioritized actions. A Safety Analysis was created resulting in the High Injury Network and 7 corridors and 14 intersections were identified.

Wilson and Company took a two-pronged approach to engagement with a survey and a public meeting. There were 586 responses with 61% supporting designing streets for all users; 35% felt safe walking; key issue is distracted driving with secondary priorities expanding awareness and supporting crash survivors. The idea is that designing roadways for more vulnerable users ensure safety for all.

Sedalia's Comprehensive Plan supported goals to make the Katy Trail Safer, certain intersections safer while supporting goals around pedestrians and bicycles. Recommendations include Safe System Approach; Taskforce selected countermeasures; HIN recommendations and implementations for higher risk intersection.

## Strategic Planning Presentation - Airport Department

Airport Director Derrick Dodson gave an overview of the Sedalia Regional Airport and goals for the upcoming year. The Airport handles 22-30 operations/day or 8,000 to 11,000 operations/year. The Airport has 2 runways, 18 hangars, 21-based aircraft and 4 privately owned hangars that are under a land lease with the City. The airport provides citizens and local businesses with air transportation and is essential to provide full service to local commerce. According to a 2012 MODOT economic impact study, the Sedalia Regional Airport has an annual economic impact of \$3.63 Million.

**Grant Based Projects:** July 2022 finished 65' x 65' box hangar and began utilizing for aircraft storage; 2024/2025 rehabilitate North parallel taxiway and Northern 500' of runway 18-36; conduct environmental assessment of wetlands and surrounding area for future South parallel taxiway project.

Other Projects: Upgrade fuel farm with electrical upgrade; upgrade self-serve fuel to cellular connection; upgrade storage area by installing garage door; remodel old terminal building into a two-bedroom suite/private pilot lounge.

#### Goals:

- · Provide safe and efficient service to all customers.
- Service more transient traffic. As an FBO (service and fuel supplier) customers receive best possible service. The Airport takes care of every flight from start to finish and as a City-owned service is more competitive than a privately-owned provider. The Airport implemented contract fueling options.
- Increase aircraft maintenance business. The Airport took possession of the former Pro-Energy hanger in January 2021. The hangar came with a ground power unit. The hangar brought 2 business aircraft to the Airport (1 Jet and 1 large twin-engine piston). The hangar gives the Airport the ability to hangar aircraft overnight. The Airport implemented fees for Jet and Turboprop aircraft.
- Add an additional position for full or part-time mechanic.
- Work towards increasing flight instruction and aircraft rental.
- Working with current tenant to get Air Evac on field.
- The storm water improvement project in the area of 28th and Quincy has been finished. As is customary in contracts of this type, estimated quantities are built into the bid and then when the contract is finished these estimates are trued up to actual amounts. In this case, the adjustment resulted in a deduction of \$11,668.00.

Community Development works with Economic Development to create jobs, stimulate local economy, increase tax base for critical City Services and maintain and improve the City's appearance which helps with recruitment efforts.

Housing Initiatives: 353 Redevelopment Corporation to provide tools, preservation credits, Neighborhood Associations and Community improvement districts for areas needing improvements; developed tax abatement guidelines and process; Historic Districts – West Central Sedalia Reconnaissance Survey and grant; Design guidelines (in process), integrate with 353 incentives, designated local landmarks, Paul Bruhn Grant (9 sub-grants); Lien clearance; property management; Planning and Zoning.

Comprehensive Plan: Completed August 2021; guiding document for City focus; Katy Depot Scenario Plan in development and construction process; Residential South Scenario Plan in development.

**Downtown:** Focus on cleanliness, sidewalks, alley lighting, depot connections; Wayfinding signs and Downtown parking lots; façade program and mini-grants; special events; developer attraction; Christmas lighting.

Initiatives/Goals: Economic Development; Marketing focus; Real Estate Management.

Mayor Dawson called for a brief recess beginning at 8:38 p.m. Meeting reconvened at 8:45 p.m.

#### Strategic Planning Presentation - Code Enforcement

Chief Building Official Bryan Kopp presented the Strategic Plan for Code Enforcement. Services are needed to provide uniform minimum standards of safety, provide regulation of minimum standards for existing structures and properties, minimum standards regulate sanitary conditions, structure and premises life-safety matters and aligns building and code regulations with aims and goals of the Sedalia 2040 Comprehensive Plan.

The Department operates under the 2021 International Code Council Codes. Building Inspectors/Code Enforcement Officers work toward additional certifications and 40% of inspection staff are new. Permitting software has operational challenges by today's standards and many code enforcement cases are years old and still in process.

#### **New Initiatives**

Investing in Staff for Retention: ICC certifications incentivized and goals mapped out through Individual Development Plans; in-house training; resources for additional training, study guides and certification exams; opportunities for continuing education credits through seminars/events; training for soft-skills such as communication and conflict resolution.

Public Engagement: Align professional standards with community standards; ICC Building Safety Month is May; website enhancements and improved end-user functionality; cross train inspectors for front desk coverage; update select zoning ordinances (sign code, accessory structure, etc.); amendment package for 2021 codes to align with regional industry standards; collaborate with Community Development and Economic Development to attract new development.

Overall Goals/Investment Strategies: Evaluate operational mechanics/philosophies and advocate more for public, partner with applicants and be development friendly; improve department training; streamline processes of permitting, plan review, building inspections and code enforcement; S.A.V.E. certified; FEMA National Incident Management System training; mutual aid and disaster response coordination; purchase iPads or tablets for inspectors; replace 2008 inspection vehicle.

#### **Building Permitting and Inspections**

Services are needed to ensure compliance with codes and standards for construction projects; ensure project compliance with life-safety and professional design standards; ensure approved code-compliant designs are followed; and clear communication with design teams, property owners and constructors helps avoid delays. Permitting and inspections are managed locally to ensure safe built environment, compliance management to communicate effectively regarding design requirements and safety standards, and primary goal of standardized building codes and standards to ensure safety and survivability of occupants and public at large.

#### **New Initiatives**

Embracing Technology: Building Inspectors having iPads or data-equipped tablets in the field for inspections in real time, access to online codes, access to digital set of approved plans, allow photos to be taken and loaded into file, allow inspectors to email applicants notices while on-site.

**Investing in Staff Certification:** Enhance ability to provide elevated level of service; more informed and equipped to assist community; additional resources, training and testing opportunities; incentivize milestone certifications.

**Fee Evaluation:** Permit fee structure evaluated for improvement; Some aspects of fee schedule very low by current standards; Current fee structure omits certain permit types resulting in low minimum fee being charged.

Improving Operational Mechanics: Issue integrated permits; management of expired permits; notify permit holders 30 days before permit expiration date; re-evaluate types of inspections conducted.

#### Property Maintenance

Services are needed to enforce property maintenance codes; provides a contact for citizens who observe or reside next to uncompliant properties; and assist the public in advocating for safe, sanitary and unblighted community. The City provides and enforces codes to enhance level of safety and quality of living conditions; prevent unkept buildings from further deterioration, blight or becoming dangerous; and to maintain community standards of aesthetics to influence property values and attract people and businesses to Sedalia.

#### New Initiatives:

Time Adjustments for Correction Notices: 10-day compliance can be unachievable for properties with larger correction items; 30-day model more effective; helps to eliminate unnecessary re-inspections and affords property owner to achieve compliance and avoid citations, fees, fines and court dates.

Investing in Staff: Time and resources for Code Officers to study and test for certifications; In-house training on adopted codes and standards; increase process efficiencies.

Councilman Hiller stated that he received a call from Rick Yeager regarding a donation from poker runs and bike show. Police Chief David Woolery was called forward and presented a check to D.A.R.E in the amount of \$250.00.

#### **GOOD & WELFARE:**

Sheri Harris, 2518 Wing Avenue, voiced concern regarding heavy traffic from Highway 65, 32<sup>nd</sup> Street and Clarendon road and people speeding through the residential area. She would like to see a two-way stop sign going north and south on Wing and Skyline.

Nancy Sims VanBuren, 422 W.T. Morris Avenue, stated she has returned to speak again about the sidewalk project and timeline. She commented on the vending machines for Narcan, stating that individuals who need it will likely remove it before needed and that people are afraid to make 911 calls. She complemented Chief Building Official, Bryan Kopp on his presentation and is pleased to see efforts to assist Citizens in fixing things.

Cale Mootz, 3365 Spring Street, stated he saw a post regarding Section 8, Ordinance 66; and Section 8, Ordinance 72 regarding removal of restrictions allowing sale and private exchange of exotic animals and the prohibition of amphibians, reptiles and invertebrates. He wished to make a case for keeping these Ordinances in place citing examples of invasive species such as Zebra Mussels, Asian Carp, Emerald Ash

Borer wasps and Burmese Pythons in Florida. Since people might not properly care for an exotic pet or have the financial means, the restrictions should stay in place and require a permit process.

Zach Gerlach, 1100 South Marvin, stated that he would like to discuss 3 Ordinances in section 8 that they would like to see changed. Ordinance 57 A lists animals allowed inside City Limits without approval of Animal Control which Includes birds, fish, Guinea pigs, hamsters, mice and turtles except where prohibited by subsections. Their group would like to see reptiles, amphibians, invertebrates and arachnids added. Ordinance 66 A prohibits the sale, trade or gifting of exotics within City Limits which limits small business and expos from coming to Sedalia. This Ordinance should be completely removed. Ordinance 72 A states that no more than 3 animals per household without Animal Control approval. Their group would like to see this amended to include exotics previously requested.

# AGREEMENT TO ESTABLISH A FUND FOR THE CARE AND SUPPORT OF CATS AND KITTENS AT THE SEDALIAANIMAL SHELTER

WHEREAS the City of Sedalia, Missouri (City) operates an Animal Shelter located at 2420 S. New York, Sedalia, Missouri, (Shelter) and

WHEREAS the Jesse E. White Jr. and Nancy A. White Trust, dated 21 August 1998 (Trust) states at Article IX, Para. (3) that the sum of One Hundred Thousand Dollars and No Cents (\$100,000.00) shall be set aside from the primary Trust for the purpose of "the care and feeding of cats and kittens", and that the funds shall be invested through Edward Jones Investments or its successor. The income from those funds shall be distributed to the Sedalia Animal Shelter, and

WHEREAS both Nancy A White and Jesse E. White Jr. are now deceased, and

WHEREAS the Trustee for said Trust, Jerusha L. White, (Trustee) is required under her fiduciary duty to the Trust to assure that the funds distributed are used for the care and feeding of cats and kittens,

Therefore, the Parties, the City of Sedalia, Missouri, the Sedalia Animal Shelter and the Trustee identified above agree as follows:

- 1. The Trustee hereby represents that she has established a fund in the amount designated above that is currently invested with Edward Jones Investments, and
- 2. The City agrees to create a separate accounting method within the Animal Control & Shelter Fund for the purpose of receiving any payments that will be made from Edward Jones, and from any and all other sources who desire to specifically donate monies for the care and feeding of the cats and kittens at the Shelter, and
- 3. That fund shall be designated "Sophie's Fund", after Jesse's (the Grantor's) beloved cat who he adopted from the Sedalia Animal Shelter and who lived with him for a year at the nursing home where he lived until he passed away, and
- 4. The Fund shall be used for such needs as the Animal Services Manager shall determine as necessary to provide care, medical treatment, food orother services, said determination(s) to be at the approval of the City's Animal Advisory Control Board (Control Board), and
- 5. When the Trustee is assured that the request for funds is approved by the Control Board, she will authorize payment to Sophie's Fund. Such funds shall be treated as restricted donations and shall only be used in accordance with the intent for which they were given, or returned to the Trustee.
- 6. The Trustee shall receive a monthly report from the Animal Services Manager and the Advisory Control Board as to the use of the Trust funds in order to assure said Trustee that the last wishes of the Grantor have been met and sustained.

#### AGREEMENT BETWEEN THE CITY OF SEDALIA, MISSOURI AND THE

#### MISSOURI DEPARTMENT OF CONSERVATION

THIS AGREEMENT is to implement the MISSOURI DEPARTMENT OF CONSER	VATION
COMMUNITY ASSISTANCE PROGRAM, and is made and entered into this	day of
20 , by and between the CITY OF SEDALIA, MISS	OURI
(City) and the MISSOURI DEPARTMENT OF CONSERVATION (Department).	

WHEREAS, the City owns tracts of land in Pettis County with two lakes totaling 15.3 acres known as Liberty Park Pond (3.0 acres) and Clover Dell Park Lake (12.3 acres) that are primarily used by the City for public fishing and recreation, and are referred to as the "Area" and are described in attached Exhibit A; and

WHEREAS, the Department and City realize the importance and need for close-to-home fishing and associated outdoor activities; and

WHEREAS, the Department and City wish to take advantage of the qualities of this Area and maximize the recreational values associated with its proper management and use.

NOW, THEREFORE, in consideration of the mutual covenants of the parties contained herein, the parties hereto do mutually agree as follows:

#### CITY RESPONSIBILITIES. The City agrees to:

- A. Allow free public access and full use of the Area for fishing and related recreational activities by the general public consistent with the Wildlife Code of Missouri and during hours established by mutual agreement of the City and the Department.
- B. Provide Area maintenance as specified in attached Exhibit B.
- C. Monitor the condition of the Area's facilities and take actions necessary to ensure that they are clean, safe and usable, including but not limited to closing facilities to public access until any dangerous conditions that may have arisen have been corrected and notifying the Department of any said closure or reopening.
- D. Provide adequate law enforcement and protective services, as much as City jurisdiction permits, for the safety and well-being of the Area's users and facilities.
- E. Give proper recognition to the Department in all brochures, advertisements or other publications concerning the Area.

- F. Prohibit fish stocking other than that recommended in writing by a Department fisheries management biologist.
- G. Manage its property within the watersheds of Liberty Park Pond and Clover Dell Park Lake to maintain both lakes' good water quality, and take no actions that will lead to the deterioration of the lakes' water quality, habitat or aquatic community.
- H. Comply with all local, state, and federal laws and regulations related to the performance of this Agreement to the extent that the same may be applicable to the City. The City agrees to assume all risks associated with the activities performed under this Agreement. Nothing in this Agreement shall constitute a waiver of sovereign immunity.
- I. Reimburse the Department for 50% of the annual cost of stocking trout for a winter trout fishery at Liberty Park Pond. The City will notify the Department in writing by May 1 if it will not be able to pay its 50% share for the upcoming winter. In the event of such notification, the winter trout fishery for the upcoming season will be cancelled.

#### 2. DEPARTMENT RESPONSIBILITIES. The Department agrees to:

- Prepare and provide a general management plan for the fishery resources of the lakes.
- B. Provide periodic fish community surveys and analysis, and manage the fisheries through proper regulations, fish stocking, manipulation of the fish populations and other fisheries management actions as determined by the Department.
- C. Enact and enforce appropriate fishing rules and regulations, and assist the City in enforcing the laws of the State of Missouri and the Wildlife Code of Missouri.
- D. Provide and maintain informational and entrance signs recognizing the City and the Department for their roles in this cooperative project.
- E. Manage the winter trout fishery at Liberty Park Pond, arrange for the trout to be stocked, and pay 50% of the annual cost of stocking trout.

## 3. JOINT RESPONSIBILITIES AND ACKNOWLEDGEMENTS. Both parties agree that:

- A. This Agreement is for the purpose of capitalizing on the value of the Area for public fishing and related outdoor activities.
- B. The Department may fund its obligations under this Agreement with any

combination of state and federal monies.

- C. The required fishing permit as defined by the Wildlife Code of Missouri and the effective regulations pertaining to the taking of fish and use of the Area will be jointly publicized whenever possible.
- D. This Agreement shall become effective upon execution by both parties. It shall expire twenty-five years from the effective date; provided, however, that it shall renew automatically for successive terms of one year each if neither party has advised the other in writing of its intention to terminate the same at least one hundred and twenty days prior to any applicable termination date.
- E. Any electronic signatures affixed to this document are intended to authenticate this writing and to have the same force and effect as manual signatures, pursuant to the Missouri Uniform Electronic Transactions Act (§432.200 et seq., RSMo).
- F. This Agreement may be amended as desired by the mutual written agreement of the parties hereto.

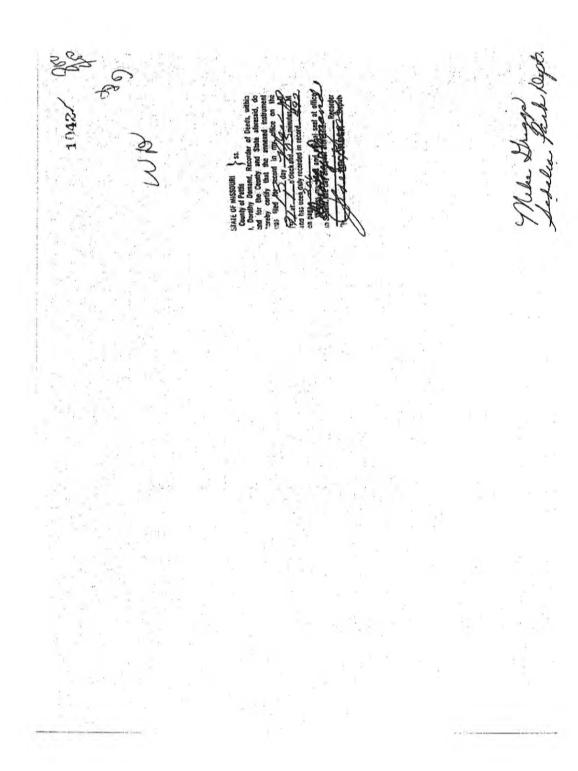

#### AREA MAINTENANCE STANDARDS

The City agrees to provide routine maintenance of the Area and facilities sufficient to keep the public use facilities in a clean, safe and usable condition. In accomplishment of this, the City agrees to:

- Clean up trash and litter at least once each week from May 1<sup>st</sup> through September 15<sup>th</sup>, and as needed during the rest of the year.
- Clean and deodorize privies at least once a week from May 1<sup>st</sup> through September 15<sup>th</sup>, and as needed during the rest of the year.
- Pump privies when liquid levels reach 75% of pit capacity or before when conditions warrant, and to make repairs to Area privies as needed.
- 4) Mow grass within 10 feet of roads, parking lots, and other public use facilities often enough to ensure that it does not exceed a height of 6 inches; and mow a 20-foot semicircle around the cantilever directional sign (if provided) often enough to ensure that vegetation does not obstruct the visibility of the sign from both directions.
- Control grass on roads and parking areas and around traffic control barriers (if present).
- 6) Provide and install rock (rip rap), as needed, to maintain any protective rocked slopes or banks in the vicinity of the provided facilities.
- Maintain asphalt roads and parking areas according to American Association of State Highway and Transportation Officials (AASHTO) standards. Routine preventative maintenance shall include the regular application of asphalt seal-coats to prevent or delay costly corrective measures. Any cracks larger than 0.5 inches shall be filled with a crack sealer, prior to the application of a seal-coat. A slurry seal coat, which is a mixture of quick setting asphalt emulsion, fine aggregate, mineral filler, additive, and water shall be applied to the surface once every five years. In places where cracks are more severe, but limited to specific areas of pumping subgrade (resulting in potholes, tire tread lanes, etc.), the old asphalt shall be removed, and any soft pumping subgrade shall be excavated and replaced with a sufficient depth of clean aggregate to stabilize the subgrade prior to asphalt replacement.
- Provide the normal, routine maintenance of Area roads, parking lots, floating fishing dock, privy, sidewalks and any other facilities needed to keep these items fully functional and to present a positive image of the City and Department to the public.

## Background

The City of Sedalia applied for an ARPA Community Revitalization Grant through the Missouri Department of Economic Development (DED) for improvements to sidewalks in the North Central Neighborhood of the city. The City was awarded the grant on March 22, 2023, in the amount of \$767,760.00. This is a matching grant, therefore the total cost of the project is \$1,535,870.00, with the City providing cash and non-cash for in-kind services.

On May 6<sup>th</sup>, 2024 City Council authorized and approved a contract with Wilson & Co. for the design of the sidewalks in the amount of \$170,688.50. Design was completed and bids were received on November 22, 2024.

As mentioned the funding for this project was for a total of \$1,535,870.00 with DED providing \$767,760.00 in cash funds and the City providing \$768,110.00 in cash and non-cash match. Based on the application the City had the following breakdown for their match:

City Match for Prep and Construction (Cash SLFRF) \$405,240.00
Engineering (Cash SLFRF) \$150,810.00
Grant Admin (Cash SLFRF) \$14,060.00
City non Cash Match (Site prep work, City Staff) \$198,000.00

## Discussion

The City received five (5) bids, one of the bids was determined to be non-responsive and is not included in the tabulations.

Based on the Engineer's estimate for the project (\$1,793,132.00) to construct the entire project, the City asked bidders to provide a cost for the entire project and provide seven (7) deduct bid alternates. The reasoning behind this was to provide as much flexibility in the bid and to use as much funding as possible.

Listed below at the engineer's estimated and the base bids from the Contractors:

Engineer EST.: \$1,793,132.00
 S & A Equipment & Builders, LLC: \$1,356,577.66
 Inco USA, LLC: \$2,061,399.32
 MegaKC Corporation: \$2,616,563.00
 Septagon Construction Company: \$3,302,619.86

S & A Equipment & Builders, LLC was the lowest and most responsive bidder.

The City has two options to proceed:

- a. Proceed with the bid of \$1,356,577.66 to construct the entire project; adding in engineering cost (\$170,688.50) brings the total cost of the project to: \$1,527,266.16. The City would then have \$8,603.84 to use for Grant Administration, and the City would have to use cash for the entire match rather than using non-cash in-kind contributions for part of the match.
- b. The other options is to remove enough deduct alternatives from the base bid (\$1,356,577.66) to bring down the amount of cash needed to match what was outlined in the Grant. This would require bringing down the construction costs to \$1,153,121.50 or a reduction of \$203,456.16. This would require to execute bid alternates 1, 2, and 3 totaling \$183,318.77 and the City would still be short \$20,137.39 and need to fund this amount or execute bid alternates 1-4 for a total of \$258,291.58 and leave \$54,835.42 on the table in grant funds from DED.

### Recommendation

It is staff's recommendation that City Council Approve the Contract with S&A Equipment and Builders, LLC in the amount of \$1,356,577.66 for the following reasons: 1) it will complete the total project now, 2) based on the bids, it does not appear the City would get favorable bids in the future indicating it would cost more later to complete the rest of the project, 3) this project will cover two (2) City budget years and the additional funding could be put into next year's budget.

# Background

The Washington Street Bridge over the UPRR consists of a single span through-truss over the railroad with a steel bent cap and stringer system of approach spans on each end. The approach spans are the focus of this Task Order.

Each steel bent cap was originally supported with a single built-up steel column at each end of the bent cap, with the column sitting on an exposed concrete foundation. Around 2014-2015, a rehabilitation project was performed to supplement the approach span steel bent cap supports by adding a steel column at the midspan of each bent cap, with the steel column sitting on an exposed concrete foundation. Other repairs included: strengthening the truss span, replacing all truss floorbeams, and replacing the stringers and deck for the entire structure. From a cursory desktop review of the rehabilitation plans, it does not appear that any work was done to strengthen existing steel columns.

In a recent routine MoDOT inspection, heavy section loss was noted in multiple original steel support columns prompting the City to close the bridge.

The City has requested HDR perform a condition assessment of the approach span substructure and provide conceptual-level repair recommendations that would allow the City to re-open the bridge. This was completed in July 2024, with a final report provided to City Council on July 8, 2024.

The City then reopened the bridge, Northbound traffic only on July 10, 2024, based on the information contained in the July 8, 2024 HDR Report. developing a comprehensive plan for repairs to open the bridge and restore two-way traffic, thereby necessitating the need to close the bridge so that initial work can begin during the design phase of the work. This will reduce the number of months required to keep the bridge closed.

## Discussion

During the initial phase of work with HRD was for a limited scope of work to provide the City with existing conditions of the bridge, proposed short, mid-term, and long-term solutions, with estimated costs. This work was completed under contract for \$9,994.00. In a Power Point presentation to City Council Option 2, was to "encase the bents in concrete with cost for engineering estimated to be \$76,000.00."

The City in partnership with HDR, INC. has requested HDR to provide the City with a Scope of Work that will provide the City with Plans and Specifications stamped by a Licensed Professional Engineer (Missouri) so the City may go out to bid for the project. These plans shall be reviewed and approved by MoDOT Bridge Section and the City and shall allow the bridge to be opened for two-way traffic with a minimum load rating of 35 tons.

Specifically, the major work will include the following tasks:

- 1. Site visit
- 2. Load Rating
- 3. Meeting with City to discuss Draft Summary Report
- 4. Provide construction plans at 50% and 90% for review and Final stamped plans

The proposed schedule provides for final signed/sealed plans be submitted to the City for bid advertisement by March 28, 2025. The Engineer's Fee for this work is \$133,409.00. As noted between the initial "encasement of concrete" fee estimated at \$76k and what is proposed is an increase of \$57,000.00. The major difference is an increase scope of work:

- 1. Load rating, which will be required by MoDOT to open the bridge
- 2. Additional plans and specifications for details beyond Column concrete encasement
- Pre-bid Services; Construction Estimate and Estimate Documentation, Job Special Provisions, answer questions during bidding
- 4. Coordination with MoDOT Bridge Section.
- 5. Stamped Plans and Specification by a Licensed Professional Engineer.

# Recommendation

City staff recommends approval of Task No. 2 in the amount of \$133,409.00 for Professional Engineering Services provided by HDR Engineering, Inc. for Plans and Specifications to rehabilitate the Washington Street Bridge that will provide for two-way traffic and with a minimum load rating of 35 tons.

#### TASK ORDER NO. 2

This Task Order pertains to an Agreement by and between City of Sedalia, ("OWNER"), and HDR Engineering, Inc. ("ENGINEER"), dated May 9, 2024, ("the Agreement"). Engineer shall perform services on the project described below as provided herein and in the Agreement. This Task Order shall not be binding until it has been properly signed by both parties. Upon execution, this Task Order shall supplement the Agreement as it pertains to the project described below.

#### TASK ORDER NUMBER: 2

PROJECT NAME: Washington Ave. over Union Pacific Railroad (UPRR) Bridge – Approach Span Load Rating

#### PART 1.0

PROJECT DESCRIPTION: The Washington Ave. bridge over the UPRR was inspected in May 2024 and was found to have severe corrosion of the approach span steel bent caps and steel columns. The bridge is currently closed to traffic due to the approach span condition.

Each steel bent cap was originally supported with a single built-up steel column at each end of the bent cap, with the column sitting on an exposed concrete foundation. Around 2014-2015, a rehabilitation project was performed to supplement the approach span steel bent cap supports by adding a steel column at the midspan of each bent cap, with the steel column sitting on an exposed concrete foundation. Other repairs included: strengthening the truss span, replacing all truss floorbeams, and replacing the stringers and deck for the entire structure. From a cursory desktop review of the rehabilitation plans, it does not appear that any work was done to strengthen existing steel columns.

The City of Sedalia has requested HDR perform capacity analysis of the approach spans to determine the load carrying capacity of the bridge with both lanes of traffic open. It is assumed that the approach spans will require repairs to strengthen and/or supplement the existing members to re-open the bridge, and the design and development of construction plan documents are part of this task order as well.

#### PART 2.0

SCOPE OF SERVICES TO BE PERFORMED BY ENGINEER ON THE PROJECT:

- A. Site visit. HDR will meet the City on-site to gather detailed measurements of existing approach span steel elements. These include the controlling elements identified in the attached highlighted framing plan, comprised of: 2 approach span floorbeams, 2 approach span columns, and 2 approach span stingers. For each element, remaining steel thickness measurements will be taken, overall member sizes, repair element sizes, locations of required repairs, and corresponding photos of each location.
- B. Load Rating

- a. Floorbeams and stringers identified in Section A above will be load rated at their current condition. Load ratings will be based on the 3<sup>rd</sup> Edition 2018 AASHTO Manual for Bridge Evaluation, LFD. Rating trucks will include HS-20 and a city-defined fire truck.
- b. Columns will be checked for overstress in their current condition
- c. A summary report of load ratings will be generated and distributed to the City and to MoDOT. In addition, a summary of conceptual recommended repairs will be provided.
- C. Meet with City to discuss Draft Summary Report. HDR will meet virtually with the City one time to discuss the draft summary report and make up to one round of revisions to the report to address City comments.
- D. The results of the report in Part C will inform what repairs will be performed on the bridge. It is assumed that repairs to the following approach span items will be required before the bridge can be re-opened to traffic:
  - a. Floorbeams (maximum of 2 different repair details to be provided)
  - b. Steel column bases (maximum of 1 detail to be provided)
  - Concrete encasement of steel column (maximum of 1 detail to be provided)
  - d. Column to floorbeam connections (maximum of 2 details to be provided)
- E. Provide construction plans, notes, engineer's opinion of probable construction cost (provided at 50% plan development, 90% plan development, and finalized with final plans), and quantities for the above noted repairs. One set of 90% plans will be developed and submitted to the City for review. One round of comments will be addressed before final signed/sealed construction plans are submitted to the City. It is estimated the following sheets will be included in the plan set:
  - a. General Plan and Elevation
  - b. General Notes and Quantities
  - c. Bridge Typical Section and Framing Plan Showing Repair Locations
  - d. Floorbeam Strengthening Details
  - e. Column Base Strengthening Details
  - f. Concrete Encasement of Steel Column Details
  - g. Column to Floorbeam Connection Strengthening Details
  - h. Bill of Reinforcing Steel
- F. Update the approach span load ratings to include the above noted repairs
- G. Items excluded from this scope of work include but are not limited to:
  - a. Review and repair of existing truss
  - b. Review and repair of existing concrete deck
  - c. Review and repair of existing railings
  - Review and repair of any additional bridge elements not explicitly stated in this scope of services

- e. Traffic control plans
- f. Workday study
- g. Railroad coordination
- Post-design services including but not limited to: pre-bid meeting, answering questions during bidding and construction, responding to RFI's, and review of shop drawings
- i. Construction observation

#### PART 3.0

OWNER'S RESPONSIBILITIES: Owner shall provide any plans or inspection reports to Engineer. Owner shall also grant access to visit the bridge site and facilitate the site visit. Owner shall review the draft summary report and provide comments back within two (2) weeks' time.
